3. The LL.M, MSc and PG Diploma programmes are all available by both part-time and full-time study. The PG Certificate is available by part-time study only.

#### Curriculum

4. All students shall undertake an approved curriculum as follows:
  - i) for the Postgraduate Certificate no fewer than 60 credits
  - ii) for the Postgraduate Diploma no fewer than 120 credits
  - iii) for the degree of LL.M or MSc no fewer than 180 credits including a 60 credit module

- Part-time students for the degree of LLM, MSc or Postgraduate Diploma shall normally require 40 credits to progress to year two.

### Award

7. **Degree of LLM/MSc:** In order to qualify for the award of the degree of LLM or MSc in Mediation and Conflict Resolution, a candidate must normally have accumulated no fewer than 180 credits, including all taught compulsory modules from the programme curriculum and 60 credits must have been awarded in respect of one of the 60 credit modules above.
8. **Postgraduate Diploma:** In order to qualify for the award of the Postgraduate Diploma in Mediation and Conflict Resolution, a candidate must normally have accumulated no fewer than 120 taught credits, including all taught compulsory modules from the programme curriculum.
9. **Postgraduate Diploma in Law:** In order to qualify for the award of the Postgraduate Diploma in Law, a candidate must have accumulated no fewer than 120 credits from the taught modules from the programme curriculum.
10. **Postgraduate Certificate:** In order to qualify for the award of the Postgraduate Certificate in Mediation and Conflict Resolution, a candidate must normally have accumulated no fewer than 60 taught credits from the programme curriculum, including all taught compulsory modules.
11. **Postgraduate Certificate in Law:** In order to qualify for the award of the Postgraduate Certificate in Law, a candidate must have accumulated no fewer than 60 credits from the taught modules from the programme curriculum.
