Certificate of Continuing Education in French

These regulations are to be read in conjunction with the [General Academic Regulations – Undergraduate, Integrated Master and Professional Graduate Degree Programme Level](#).

Admission

1. Applicants for admission to the programme for the Certificate of Continuing Education in French must normally satisfy the General Entrance Requirement or offer suitable alternative evidence of educational ability acceptable to the Board of Study.

Duration

2. The programme is offered on a part-time basis only, normally over a period of three years and not less than two academic sessions. Subject to these provisions, the Board of Study may grant exemption from part of the programme to a candidate who submits such evidence of academic fitness as the Board considers acceptable.

Mode of Study

3. The programme is available by online study only.

Curriculum

4. All students shall undertake modules amounting to 120 credits as follows:
