These regulations are to be read in conjunction with the <u>General Academic Regulations</u> - Postgraduate Taught Degree Programme Level.

These regulations apply to entry on the above programmes from Academic Year 2023/24 only.

Admission

- 1. Notwithstanding the <u>General Academic Regulations Postgraduate Taught Degree Programme Level</u>, candidates shall normally possess:
 - i. a degree from a United Kingdom University; or
 - ii. other qualifications deemed, by the Programme Leader of the relevant study route, acting on behalf of Senate, to be equivalent to i. above including the Postgraduate Diploma in Business Administration or its equivalent; or
 - iii. be deemed, by the Programme Leader of the relevant study route, acting on behalf of Senate, to have achieved an academic standard equivalent to i. above.
- 2. In addition, all successful applicants will be required to have had a period of relevant managerial experience. For applicants holding a degree of a University in the United Kingdom, or an equivalent academic or professional qualification, the period is normally three years. Other applicants, who lack formal qualifications but have substantial managerial experience should have a minimum of five years of relevant experience.
- Applicants holding the MSc in Business and Management from the University of Strathclyde wishing to convert this degree to the MBA will apply for Recognition of Prior Learning (RPL) following the University Policy on the Recognition of Prior Learning and Credit Transfer. On qualifying for the award of the MBA, students will be required to surrender the MSc.
- 4. Applicants may also be required to obtain a satisfactory score in an admissions test and/or be called for interview.
- 5. Where applicable for accreditation purposes, applicants with an undergraduate degree from a United Kingdom University with a lower second class (2:2) classification or lower, or its equivalent must complete a mandatory pre-sessional course (Executive MBA at International Centres only).

Duration of Study

6. The <u>General Academic Regulations - Postgraduate Taught Degree Programme Level</u>, shall apply.

7. Notwithstanding the <u>General Academic Regulations - Postgraduate Taught Degree</u>

<u>Programme Level</u>, the Postgraduate Diploma in Business Administration the minimum duration of study will be 18 months and the maximum duration of study will be 48 months.

Mode of Study

8. The programmes are available by full-time and part-time study, except for the Master of Business Administration (Executive) and the Postgraduate Diploma in Business Administration which are available by part-time study only.

Examination, Progress and Final Assessment

- 10. See General Academic Regulations Postgraduate Taught Degree Programme Level.
- 11. The final award will be based on performance in all elements of the programme.
- 12. **Degree of MBA:** In order to qualify for the award of the degree of Master of Business Administration, a candidate must have performed to the satisfaction of the Board of Examiners and must have accumulated no fewer than 180 credits of which at least 40 must have been awarded in respect of the dissertation (or equivalent) MB948/MB949 Research Dissertation, MB950/MB951 Consultancy Project or MB952/MB953 Entrepreneurial Project.
- 13. **Degree of MBA (Executive):** In order to qualify for the award of the degree of Master of Business Administration (Executive), a candidate must have performed to the satisfaction of the Board of Examiners and must have accumulated no fewer than 180 credits of which at least 40 must have been awarded in respect of the dissertation (or equivalent) MB948/MB949 Research Dissertation, MB950/MB951 Consultancy Project or MB952/MB953 Entrepreneurial Project.
- 14. **Postgraduate Diploma:** In order to qualify for the award of the Postgraduate Diploma in Business Administration, a candidate must have accumulated no fewer than 120 credits from the taught modules of the programme.
- 15. **Postgraduate Certificate:** In order to qualify for the award of the postgraduate Certificate in Business Administration, a candidate must have accumulated no fewer than 60 credits from the taught modules of the programme.
- 16. **MBA with Specialisation:** In order to qualify for the award of the degree of MBA with Specialisation in a given topic, a candidate must have undertaken the 40 credit dissertation (or equivalent) MB948/MB949 Research Dissertation, MB950/MB951 Consultancy Project or MB952/MB953 Entrepreneurial Project in an area related to the chosen specialism, along with a further 20 credits in the chosen specialism from the optional modules listed in the curriculum.

- 17. **Postgraduate Diploma:** In order to qualify for the award of the Postgraduate Diploma in Business Administration in a named subject, a candidate must have accumulated no fewer than 120 credits from the taught modules of the programme.
- 18. **Postgraduate Certificate:** In order to qualify for the award of the postgraduate Certificate in Business Administration in a named subject, a candidate must have accumulated no fewer than 60 credits from the taught modules of the programme.

Transfer

- 19. In relation to the transfer from the Postgraduate Diploma in Business Administration to the degree of Master of Business Administration the relevant parts of the <u>General</u> <u>Academic Regulations - Postgraduate Taught Degree Programme Level</u> shall apply as appropriate.
- 20. At the Board of Examiners' discretion, a student who fails to meet the requirements for the award of the MBA may be considered for transfer to an award of the Postgraduate Diploma in Business Administration. A student in this category will automatically be barred from re-enrolment on the MBA programme on the basis of this Diploma in Business Administration.
