Mode of Study

4. The programmes are available by full-time and part-time study and by distance learning.

Curriculum

5. All students shall undertake an approved curriculum as follows:
 - i. for the Postgraduate Certificate no fewer than 60 credits
 - ii. for the Postgraduate Diploma no fewer than 120 credits
 - iii. for the Degree of MSc no fewer than 180 credits including a dissertation.

Award

8. **Degree of MSc:** In order to qualify for the award of the degree of MSc in Business Analysis and Consulting, a candidate must have accumulated no fewer than 180 credits, of which 60 must have been awarded in respect of the dissertation MS931(Sept) or MS835 (Jan) on campus or MS810 (online).
9. **Postgraduate Diploma:** In order to qualify for the award of the Postgraduate Diploma in Business Analysis and Consulting, a candidate must have accumulated no fewer than 120 credits from the taught modules of the programme.
10. **Postgraduate Certificate:** In order to qualify for the award of the Postgraduate Certificate in Business Analysis and Consulting, a candidate must have accumulated no fewer than 60 credits from the taught modules of the programme
