Progress

10. In order to progress to the second year of the programme, the [General Academic Regulations – Undergraduate, Integrated Master and Professional Graduate Degree Programme Level](#) shall apply. In addition, students must have passed BF134 Academic Skills with a mark of 60 or above by the second attempt and to have passed the remaining 90 credits of the first year of the programme curriculum with a Credit Weighted Average of 60 across those credits by the second attempt.
11. In order to progress to the third year of the programme, the [General Academic Regulations – Undergraduate, Integrated Master and Professional Graduate Degree Programme Level](#) shall apply. In addition, students must have passed BF205 Leadership Development Programme 1.
12. In order to progress to the fourth year of the programme, the [General Academic Regulations – Undergraduate, Integrated Master and Professional Graduate Degree Programme Level](#) shall apply. In addition, students must have passed BF307 Leadership Development Programme 2.

Final Assessment and Honours Classification

13. The final Honours classification for the degree of Bachelor of Business Administration with Honours will normally be based on the first assessed attempt at Level 4 modules taken in the fourth year.
